31.28 Acres of Grassland at Ty-Cerrig, Newbridge on Wye Llandrindod Wells, Powys, LD1 6ND

Sunderlands are instructed to offer a total of 31.28 acres / 12.66 hectares of productive grassland and useful grazing for the 2024 grazing period. The land is very well fenced and forms a single block with very good roadside frontage and access.

The land is available from 8th April 2024 for sheep only until the 31st October 2024 under a Grazing Licence. The land has access to natural water and some tanks and forms a good block of summer grazing.

The Vendor will claim the BPS.

DIRECTIONS

Ty-Cerrig is located just outside the village of Newbridge-on-Wye. From Builth Wells take the A470 and go through the Village of Newbridge on Wye, turn left on exiting the village onto the B4358 towards Llanafan/Beulah, after approximately half a mile turn right onto an unclassified Council road, follow this for about a mile and turn left at the cross roads, follow this for another mile and the land is located opposite Ty-Cerrig Farm.

Available from 8th April to 31st October 2024 Water tanks in some enclosures and natural water supplies Sheep only No mowing without an agreement or consent from the Licensor.

TERMS & CONDITIONS

- 1. The agreement will commence once the Grazing fee has been paid in full and Agreement as prepared by Sunderlands has been signed and completed.
- 2. The Licensor of the land will claim the BPS, the Licensee is not to breach any obligations under the scheme.
- 3. The Licensee is to comply with all legal requirements and to indemnify the Licensor for all losses and expenses relating to any non-compliance with legislation.
- 4. The Licensee is not to bring or allow any dangerous unfit or diseased animal on to the land and shall promptly remove any infected, injured or troublesome animals from it.
- The Licensee must ensure that the land does not become poached by the livestock.
 There is to be no supplementary feeding on the land with the Licensors prior written consent.
- 6. The Licensee will be the keeper of the animals for DEFRA/RPA purposes and will be solely responsible for their supervision.
